- If the vote is to change the status to a department, then the question of which school should house GSE and on the basis of which criteria should be part of the deliberation.

757 2018/2019 Commencement New Model

The Senate in its meeting of December 11, 2018 voted on and approved a resolution on the Commencement New Model:

The Senate is in agreement with the need for a change in the model of the commencement, in the better interest of the university community. The Senate would like to remind the president and provost that the Senate is a core constituent of shared governance, especially in matters pertaining to academic life, which includes the conferring of degrees, and should have been involved in more detail in the process of changing the model of the commencement. Furthermore, the schools must understand the details of executing the needed change.

The Senate demands that the schools are informed of how to prepare for the change in detail, as well as availing any necessary resources. The decision about the best model to be adopted and any related details should follow due process by involving Senate committees and other stakeholders in any upcoming discussions during the Spring semester in preparation for the June commencement.
