11. HUSS Proposed Curriculum Change: Adoption of a New Minor in Translation Objectives:

The Minor in Translation is a practice-oriented program that focuses on how translation can be applied to real-life situations to equip graduates to become professionals in a range of in-demand fields. The translation is an area with a broad scope of focus that relates to issues pertaining to culture and meaning formation. Our program highlights the interdisciplinary nature of humanities, fosters research, and innovation, and builds intercultural understanding.

The Provost Council members approve the adoption of a New Minor in Translation.

12. HUSS Proposed Curriculum Change: Change of name of Arabic and Islamic Studies BA program and removal of concentrations from the Arabic Studies

Summary of Changes:

Changing the name of the BA degree from "Arabic Studies, with specializations in Arabic Literature, Middle Eastern History and Islamic Art and Architecture (B.A.)" to "Arabic and Islamic Studies (B.A.)" and making the descriptive and introductory text clearer and more learner-centered.
