A negative test result is required and is considered valid for 48 hours from departure time at the country of departure. (Please see the pre-travel test rules for detailed guidance.)</li> <li>Unvaccinated children below the age of 12 years travelling with fully vaccinated or recovered parent/s will follow the same rules that apply to their parent/s and are not required to have a pre-travel PCR test but only post-arrival test (Rapid Antigen Test) at the following locations:               <ol style="list-style-type: none"> <li>Citizens and Residents: at any public/private clinic within 24 hours of arrival in Qatar but must sign an Undertaking form.</li> </ol> </li> </ul> |

b. GCC Citizens (non-resident) and Visitors: if parent/s are exempted from quarantine, testing for children will be at the port of entry (airport, land, sea) upon arrival in Qatar; if parent/s are subject to hotel quarantine, testing will be at the quarantine hotel.

- Non-residents of Qatar must register via the pre-travel registration system for people entering the State of Qatar on [www.ehteraz.gov.qa](http://www.ehteraz.gov.qa) website and upload all relevant official documents, where applicable, such as vaccination certificates, evidence of previous COVID-19 infection, serology antibody test results (for conditional vaccines), and PCR lab result at least 3 days before arrival
- Self-testing of Rapid Antigen is not applicable to travelers. Post-travel/upon arrival Rapid Antigen Testing must be conducted at an authorized healthcare facility: (Please see our post-travel testing policy for detailed instructions) as follows:
  - a. Citizens and Residents: at any public (PHCC) or Private clinic.
  - b. GCC Citizens (non-resident) and Visitors: anyone subject to home quarantine with first-degree relatives shall have their testing done at any authorized private clinics; for unvaccinated children below 12 yrs old who are accompanied by parent/s exempted from quarantine, testing will be at the port of entry (airport, land, sea).
  - c. Travelers who are subject to hotel quarantine will have their testing done at the hotel.
- Passengers who are required to complete quarantine in a hotel quarantine facility must book a Welcome-Home quarantine package through Discover Qatar's website <https://www.discoverqatar.qa/welcome-home/>.
- For unvaccinated travelers, their health status in the Ehteraz app will be Yellow because they are under quarantine (please review the quarantine policy for detailed instructions).

**Group 1: Citizens and Residents of Qatar**

**A- Qatar Citizens**

1- Standard Health measures:

- Fully Vaccinated / Recovered:

- Do not Required COVID-19 Test before Traveling to Qatar, Exempted from quarantine, Rapid Antigen Test within 24 hours of arrival.

- Unvaccinated / Non-Immune:

- Do not Required COVID-19 Test before Traveling to Qatar, 5 days Home quarantine, PCR test within 24 hours of arrival, plus Rapid Antigen Test on day 5 of home quarantine.

2- Red Health Measures:

- Fully Vaccinated / Recovered:

- Do not require COVID-19 Test before Traveling to Qatar, Exempted from quarantine, Rapid Antigen Test within 24 hours of arrival.
- Unvaccinated / Non-Immune:
  - Must submit a negative pre-travel PCR lab result with validity of 48 hours from departure time at the country of origin, 5 days Home quarantine, PCR test within 24 hours of arrival, plus Rapid Antigen Test on day 5 of home quarantine.

**B- Residents (Standard Health measures):**

1- Standard Health measures:

- Fully Vaccinated / Recovered:
  - Do not require COVID-19 Test before Traveling to Qatar, Exempted from quarantine, Rapid Antigen Test within 24 hours of arrival.
- Unvaccinated / Non-Immune:
  - Do not require COVID-19 Test before Traveling to Qatar, 5 days Home quarantine, PCR test within 24 hours of arrival, plus Rapid Antigen Test on day 5 of home quarantine.

2- Red Health Measures:

- Fully Vaccinated / Recovered:
  - Do not require COVID-19 Test before Traveling to Qatar, Exempted from quarantine, Rapid Antigen Test within 24 hours of arrival.
- Unvaccinated / Non-Immune:
  - Must submit a negative pre-travel PCR lab result with validity of 48 hours from departure time at the country of origin, 5 days **Hotel** quarantine, Rapid Antigen Test on day 5 of Hotel quarantine

**Group 2: GCC Citizens (who are Non-Residents)and Visitors**

**A- GCC Citizens (who are Non-Residents)**

1- Standard Health measures:

- Fully Vaccinated / Recovered:
  - Optional pre-travel RT-PCR, Exempted from quarantine, Rapid Antigen Test in private clinic within 24hrs of arrival (this is not required in case of presenting Pre-travel RT-PCR upon arrival).
- Unvaccinated / Non-Immune:
  - Must submit a negative pre-travel PCR lab result with validity of 48 hours from departure time at the country of origin, 5 days Hotel, **or** Home quarantine for those with first-degree relatives (on condition that a proof of relationship and residence is provided), Rapid Antigen Test on day 5 of Hotel/Home quarantine.

2- Red Health Measures:

• Fully Vaccinated / Recovered:

- Must submit a negative pre-travel PCR lab result with validity of 48 hours from departure time at the country of origin, 1-day Hotel quarantine, Rapid Antigen Test on day 1 of hotel quarantine.

• Unvaccinated / Non-Immune:

- Must submit a negative pre-travel PCR lab result with validity of 48 hours from departure time at the country of origin, 5 days Hotel quarantine, Rapid Antigen Test on day 5 of Hotel quarantine.

**B- Visitors (Standard Health measures):**

1- Standard Health measures:

• Fully Vaccinated / Recovered:

- (Optional) Pre-travel RT-PCR if traveler is a resident of a GCC country, or an EU national/resident. (Mandatory) negative RT-PCR is required for other travelers / Exempted from quarantine, If a resident of GCC country or an EU national/resident who does not have a pre-travel PCR, the traveler must proceed to any authorized private clinics for Rapid Antigen test within 24hrs of arrival; otherwise, not applicable.

• Unvaccinated / Non-Immune:

- Must submit a negative pre-travel PCR lab result with validity of 48 hours from departure time at the country of origin, 5 days Hotel, or Home quarantine for those with first-degree relatives (on condition that a proof of relationship and residence is provided), Rapid Antigen Test on day 5 of Hotel/Home quarantine.

2- Red Health Measures:

• Fully Vaccinated / Recovered:

- Must submit a negative pre-travel PCR lab result with validity of 48 hours from departure time at the country of origin, 1-day Hotel quarantine, Rapid Antigen Test on day 1 of hotel quarantine.

• Unvaccinated / Non-Immune:

- Not allowed to enter.

• **Test costs:**

- PCR Test: 160 QR
- Rabid Antigen: 50 QR
- Serology Antibody test (point of care): 50 QR

**PCR:**

- Passengers must take a PCR test result at a medical centre accredited by the health authorities in the country of departure. The test result must be negative and must be done 48 hours before arrival in Qatar.

**Travelers who have recovered from COVID-19:**

**Vaccine:**

- **Approved Vaccines:** (Pfizer / BioNTech - Moderna (SpikeVax) - AstraZeneca (Covishield / Oxford / Vaxzevria) - Jansen / Johnson & Johnson )
- **Conditionally Approved vaccines:** (Sinopharm vaccine – Sinovac - Sputnik V)
- **Immunity Status:**
- **Immune-Vaccinated:** Anyone who received any of the following COVID-19 vaccine approved/recognized by the Ministry of Public Health within its immunity validity period:
  - Valid for nine (9) months from fourteen (14) days after 2nd dose vaccination of Pfizer, Moderna, Astra Zenica COVID-19 vaccines.
  - Valid for twelve (12) months after the booster dose vaccination of Pfizer, Moderna, Astra Zenica COVID-19 vaccines.
  - Valid for nine (9) months from 2 weeks after the 1st dose of Jansen & Jansen COVID-19 vaccine.
  - Valid for twelve (12) months from seven (7) days of receiving the booster dose of Jansen & Jansen COVID-19 vaccine.
  - Valid for six (6) months from fourteen (14) days after the 2nd dose or booster dose of conditionally approved COVID-19 vaccines, where a positive Serology on Antibody Test lab result is required and is valid for 30 days from testing; If the traveler is unable to take a Serology Antibody test in the country of origin or if the Antibody test result appear negative, the traveler must undergo relevant quarantine for 5 days; Those who received booster dose using MOPH approved vaccines immune status is extended to twelve (12) months from fourteen (14) days after the booster dose and Serology Antibody test is no longer required.
- Anyone who had a medically confirmed COVID-19 infection acquired either locally or overseas is considered to have immune status valid for twelve (12) months from the date of the infection. There should be an official and verifiable laboratory test result as evidence of the past infection.
- Passengers who are fully immunized outside Qatar with a vaccine approved by the Ministry of Public Health of Qatar are required to submit the original vaccine certificate and other supporting documents written in Arabic or English proving that they have obtained the vaccine, as follows:
  - The name of the traveler must be identical to that on the passport.
  - Dose dates by vaccine type (one dose for Jansen vaccine and two doses for other vaccines).

**ARAB NATIONALS RESIDING IN NON-RESTRICTED COUNTRIES:**

Lifting the restriction on Arab nationals residing in non-restricted countries, provided that they are holding a valid residence in the country of residence at least six months and return ticket, except Arab nationals residing in turkey.

b) Maintaining the instructions related to the entry of Syrians to Jordan, which requires that residents are allowed entry into Jordan, provided that they hold residency in those countries. noting that residents of the European union are required to obtain prior approval for the existence of a reverse wave of asylum for Syrians who have obtained asylum in those countries, with the assurance that Syrian businessmen, investors, and their family members can enter Jordan using investor's card, or commercial registry regardless of where they come from.

**PASSENGERS TRAVELLING TO JORDAN FOR MEDICAL PURPOSES DIRECTLY FROM IRAQ, LIBYA, YEMEN, SUDAN, CHAD, AND ETHIOPIA**

Categories other than mentioned in point no.2 above) are exempted from the condition of applying for a pre-visa for: a) men above 50 years old, children under 15 years old, and women from all ages (except male patients arriving from Sudan). b) Patients who had previously entered into Jordan legally and had surgeries or medical procedures and left Jordan after that within the legal period and need to return to continue treatment or obtain a new treatment service. c) Two escorts are allowed for each patient, provided that they are first-degree relatives of the patient. Moreover, minor escorts are also allowed to enter regardless of the number.

**LIFTING THE RESTRICTIONS ON NATIONALS OF ALBANIA AND MOLDOVA.**

Accordingly, nationals of these two countries will grant entry visas either through Jordanian diplomatic missions abroad or border posts upon arrival Jordan without the need for prior approval from ministry of interior.

**GRANTING ENTRY FOR HOLDERS OF ENTRY VISAS TO THE UNITED STATES OF AMERICA OR SCHENGEN VISAS**

visas either through Jordanian diplomatic missions abroad or through border posts upon arrival Jordan without the need for prior approval for nationals of restricted countries who have entry visas to the united states of America or Schengen visas (with the exception of the people of the Gaza strip who hold Palestinian passports and holders of Palestinian passports for external use, nationals of Iran, Afghanistan, Iraq, Nigeria, Bangladesh, holders of Arab and foreign travel documents of all kinds, and Syrians).

**TOURIST GROUPS OF THE FOLLOWING COUNTRIES NATIONALITIES ARE ALLOWED ENTRY INTO JORDAN AS FOLLOWING:**

Nationals of Nigeria, Philippines, Colombia, Pakistan, and Libya are allowed entry without the need for prior approval, provided that they enter within a tourist group of no less than five people, within an approved tourism program, and that their entry and exit to/from the country are within an approved competition with the presence of departure guarantees by tourist offices.

b) nationals of Syria are allowed entry after the tourism offices duly submitted an application to the ministry of interior and the tourism office pledged that these groups would adhere to the pre-prepared tourist program and inform ministry of interior of any escape case with the intention of settling in the country and keep their passports with the tourism office that brought them until their departure country.

### **JORDANIAN PASSENGERS ARRIVING FROM UKRAINE AND THEIR WIVES AND CHILDREN**

Who are either Ukrainians or holding any other nationality are exempted from providing PCR test before 72 hours of departure, submit their information on visit Jordan platform to issue QR code, and conduct PCR test upon arriving in Jordan provided that they hold proof of marriage regardless of the validity of their passports (Jordanian, Ukrainian, or any other nationality). Above new requirements also apply on passengers holding either Palestinian passport or cards and connecting to west bank.

International scheduled flights are allowed to operate from/to Jordanian airports. The following to be applied to all inbound flights:

1- Airlines are responsible to ensure the following requirements are met by all non-Jordanian passengers prior to boarding

a) **Non Jordanian passengers** are required to **visit <https://www.visitjordan.gov.jo>** portal prior to departure, complete the required form, and obtain the QR code which is mandatory to be presented to airline personnel prior to boarding and upon arrival.

**-Exemptions include:**

-Jordanian passengers and their families, wives and children regardless of their nationality.

- transit passengers

b) Proof of health insurance is mandatory for non-Jordanians.

**- Exemptions include:**

- **Medical tourism patients.**

- **Diplomatic or holders** (diplomats and employees of regional and international organizations (and their dependents and family members holding diplomatic passports, special passports, or regular passports) have a permanent diplomatic QR code that its validity does not expire, and it is possible to return with this code to Jordan for several trips

- **military or holders**, are allowed entry into Jordan provided health insurance for non-Jordanians.

The following shall be applied on passengers coming from (**South Africa, Lesotho, Zimbabwe, Mozambique, Namibia, Eswatini, and Botswana**) is totally **prohibited**.

- Passengers coming from the above mentioned countries, the following shall be applied on:

**A- Jordanian passengers and their families (spouse and children):**



- who were in the above countries in the last 14 days prior to traveling to Jordan are allowed entry into Jordan provided below conditions:
  - Provide negative PCR test conducted within 72 hours prior to the departure time. Exemptions include (children under the age of 5 years)
  - Conduct PCR test upon arrival. EgyptAir is responsible to collect the amount of the arrival PCR test (28 JOD) in the form of an EMD for all passengers who are unable to pay through the <https://www.visitjordan.gov.jo> portal. Exemptions include (children under the age of 5 years)
  - Undergo institutional quarantine upon arrival at the airport hotel for 14 days as following:
    - sign the attached indemnity form
    - pay to the hotel the required charges for the whole nights in advance
    - Airline is responsible to keep a copy of the indemnity form and hotel receipt for a period of 60 days to be provided to CARC upon request.

**B- (NON- JORDANIAN):** passengers who were in the above countries in the last 14 days are not allowed entry and transit Jordan.

**C- (JORDANIAN) & (NON- JORDANIAN):** passengers and their families (spouse and children who stayed more than 14 days outside above countries prior to traveling to Jordan are allowed entry into Jordan by applying requirements under point a and b above secondly.

- Passengers shall submit a health declaration at the counter before boarding.
- Any passenger gives falsified or incorrect information is subject to a fine of 10,000 JOD.
- International transfer passengers are allowed at Jordanian airports, and all transit passengers must hold a negative PCR test which was conducted within 72 hours before departure.
- **Effective 24th February till 24th May 2022,** Jordanian passengers arriving from Ukraine and their wives and children who are either Ukrainians or holding any other nationality are exempted from providing PCR test before 72 hours of departure, submit their information on visit Jordan platform to issue QR code, and conduct PCR test upon arriving in Jordan provided that they hold proof of marriage regardless of the validity of their passports (Jordanian, Ukrainian, or any other nationality).  
Above new requirements also apply on passengers holding either Palestinian passport or cards and connecting to west bank.

**PCR:**

- All arriving passengers are required to have a valid QR code for the flight, **negative PCR test conducted within 72 hrs prior to departure time from the first embarking airport,** regarding **Egypt,** Turkey, and Iraq only PCR tests from approved labs should be accepted.
  - **Exemptions include** Children under the age of **5 years and diplomats.**

**PCR/ QUARANTINE:**

**Effective 04th April 2022, the following new instructions are applied:**

**In-bound Passengers:**

- 1- All Passengers who are fully vaccinated with the two dose of the approved vaccines for COVID-19 are not required to provide a pre departure Covid-19 PCR test result, also these passengers are not required to conduct repeat PCR test upon their arrival in Nigeria.
- 2- All passengers who are 18 years old and below will have the same privileges as persons who are fully vaccinated.
- 3- All passengers who are partially vaccinated or unvaccinated are required to be in possession of a negative Covid-19 PCR test result done within 48 hours calculated from the sample collection to the first point of acceptance. This type of passengers must book online, before being accepted on board EgyptAir flights, for repeat Covid-19 PCR test on days 2 and 7 upon arriving Nigeria. **This requirement however doesn't apply to passenger below 18 years of age**
- 4- All inbound passengers MUST register via the online Nigerian International Travel Portal <https://nitp.ncdc.gov.ng/>  
To get the QR code or the Permit to Travel which is Mandatory and MUST be presented at the check in counter before being accepted on board EgyptAir flight to LOS. Only the partially vaccinated and the non-vaccinated passengers will pay for the two post arrival PCR tests Online.
- 5- Airlines who will fail to comply with all the pre boarding requirements shall attract a penalty of 3500 USD per passenger.

**A. PRE-DEPARTURE FROM COUNTRY OF EXIT:**

**I. Pre-Boarding:**

- Travelers MUST perform a COVID-19 PCR test **not more than 2 days (48 hours)** before boarding/departure. PCR tests done more than 48 hours before departure are not valid and persons will not be allowed to board. Rapid antigen or antibody test are not acceptable; only PCR tests can be used for this purpose. Test validity commences from the time of sample collection. For Travelers with multiple connections before arrival in Nigeria, the PCR test must be valid within 48 hours of boarding from the first point of departure. Travelers must bring along an electronic or hard copy of their negative COVID- 19 PCR test for presentation at the departure airport and upon arrival in Nigeria. A record of their vaccination status will also be required on arrival in Nigeria.
- All intending Travelers (**including diplomats and children less than 10 years old**) MUST register via an online national travel portal (Nigeria International Travel Portal – <https://nitp.ncdc.gov.ng>) and proceed to fill in the

online Health Declaration/ Self-Reporting form located on the portal. They should ensure that the information/contact details provided on the form are correct and verifiable. Travelers must provide valid phone numbers, residential addresses, and functional e-mails where they can be contacted. Travelers must also inform Port Health officials on arrival of any change in their health status since completion of the Health Declaration/Self-Reporting Form.

- After filling the online Health Declaration/Self-Reporting Form, Travelers will be directed to upload their negative COVID-19 PCR test on to the portal. **Only children less than 10 years old are exempted from uploading a pre-arrival negative COVID-19 PCR test result.** Once this is successfully done, Travelers will proceed to the payment section of the travel portal. **Only Children less than 10 years are exempted from payment for the repeat test in Nigeria.** Travelers are advised to still bring along an electronic or hard copy of their negative COVID-19 PCR test for presentation at the airport.

➤ **For partially vaccinated and unvaccinated Travelers:**

On reaching the payment section of the portal, Travelers will be requested to select their preferred Laboratory/Sample Collection Centre based on where they will be self-isolating for the period of 7-days in Nigeria. A list of accredited private laboratory providers/Sample Collection Centers across the country are available on the payment platform. The next stage is to choose a bank payment gateway and then proceed to pay for the **Day 2 (arrival day + 1 day)** and **Day 7 (arrival day + 6 days)** in-country COVID-19 PCR tests. Please **note** that Travelers paying in Naira should use cards issued by a Nigerian bank.

➤ **For fully vaccinated Travelers:**

- On reaching the payment section of the portal, Travelers will be requested to select their preferred Laboratory/Sample Collection Centre based on where they will be located 2 days after arrival in the country for the Day 2 test (arrival day + 1 day). A list of accredited private laboratory providers/Sample Collection Centers across the country are available on the payment platform. The next stage is to choose a bank payment gateway and then proceed to pay for the **Day 2** in-country COVID-19 PCR test. A record of their vaccination status will also be required on arrival in Nigeria.
- Following successful payment, Travelers should download the **Permit to Travel Certificate/ QR Code** using the “Get Permit to Travel” button visible at the top right corner of the portal, save and print the form for presentation at the point of boarding. The Permit to Travel Certificate/ QR code will have a “PAID” label if payment is successful and “UNPAID” label if payment had not gone through yet or is unsuccessful. Any passenger with an “UNPAID” label will not be allowed to travel. A copy of the Permit to Travel Certificate/QR Code will also be sent to the email address provided by the traveller.

**II. Boarding:**

1. Prior to boarding for Nigeria, Travelers **MUST** present **TWO** documents at their point of departure to be allowed to board.
  - a. A **negative COVID-19 PCR** test done within 2 days (**48 hours**) of departure. Airlines have been directed not to board Travelers with non-PCR COVID-19 tests (such as antigen or antibody tests), a positive COVID-19 PCR test result, or tests performed beyond 48 hours of boarding; and
  - b. **Permit to Travel Certificate/QR Code** - generated from the Nigeria International Travel Portal on completion of a health questionnaire, uploading of a negative COVID-19 PCR result and schedule of PCR tests on Days 2 and 7 on arrival in Nigeria. Travelers failing to show a Permit to Travel Certificate/QR Code will not be allowed to board.
2. Airlines that board Travelers without any of the required documents (a negative COVID-19 PCR test done not more than 48 hours prior to boarding and a Permit to Travel Certificate/QR code, shall be sanctioned as follows:
  - a. Travelers, who are non-Nigerians, will be refused entry and returned to the point of embarkation at cost to the airline
  - b. Travelers who are Nigerians or holders of permanent resident permit will be allowed entry but subjected to the procedure outlined in Section D below. In addition, **Travelers arriving with forged (fake) COVID-19 PCR results will be escorted to a designated quarantine facility (government approved hotel) for a mandatory quarantine for a period of 7 days at expense to the traveler and will be prosecuted.**
  - c. Airlines shall be fined **USD 3,500** per traveler for failure to comply with any of the preboarding requirements.
  - d. Airlines who consistently fail to comply with the above requirements may be banned from coming to Nigeria.
3. At the time of boarding, Travelers will be required to undergo temperature screening and asked about COVID-19 symptoms. Travelers with temperature >38C and other COVID-19 related signs and symptoms shall not be allowed to board the flight.

**B. ON ARRIVAL IN NIGERIA**

- All Travelers are required to strictly adhere to instructions given by Port Health Services at the arrival terminal. Travelers who fails to adhere to instructions will be sanctioned by relevant security personnel.

**All Travelers arriving in Nigeria will be required to:**

1. Go through the routine Port Health screening and present electronic or print-out evidence of **preboarding COVID-19 PCR test, Permit to Travel Certificate/ QR Code; and Vaccination Certificate (where applicable);** and
2. Present their international passports for clearance through the Nigerian Immigration Service System's Migrants Identification Data Analysis System (MIDAS).

**For partially vaccinated and unvaccinated in-bound Travelers:**

- Proceed on **mandatory 7 days** self-isolation/quarantine in their selected in-country destination address. Travelers are to avoid physical interaction with friends, family members, colleagues, and other members of the public during

the period of self-isolation. Travelers should check their emails/text messages regularly for updates regarding the arrangement for their repeat COVID-19 PCR test from the laboratory of their choice. During this period the traveler may be contacted by the COVID-19 Response team to ascertain state of self-isolation, Days 2 & 7 testing appointment and health status.

- Show-up at the laboratory/sample collection centers on the **2nd and 7th day of arrival**. Samples will be taken, and a COVID-19 PCR test done. The selected private laboratory will send a reminder text message, email, or phone call to the traveler a day before the appointment date.
- Persons who test negative for COVID-19 after 7 days of self-isolation/quarantine will be allowed to exit self-isolation on receipt of their result.

**For fully vaccinated in-bound Travelers:**

Show-up at the laboratory/sample collection centers on the **2nd day of arrival**. Samples will be taken, and a COVID-19 PCR test done. The selected private laboratory will send a reminder text message, email, or phone call to the traveler a day before the appointment date.

**C. NOTE:**

- a. Travelers who fails to show up at the sample collection centers on Days - 2 and 7 of arrival (as applicable) will be sent text reminders and their details forwarded to the State Public Health Department teams and Nigeria Centre for Disease Control (NCDC) for active follow-up.
- b. Travelers who fails to show up for testing will have travel restrictions placed on their passports for at least 6 months and will not be able to travel abroad during this period. Non-Nigerian passport holders will have their visas revoked and will be deported from the country.
- c. Test results will be provided within 24 hours and the State Public Health Departments & NCDC will be informed; accordingly, if test result is not received after 24hrs, the traveller may contact the private Laboratory for his/her test result.
- d. Partially vaccinated or unvaccinated persons who test negative for COVID-19 after 7 days shall end self-isolation on receipt of a negative test result but must continue to self-monitor for symptoms until Day 14; and MUST continue to observe Non-Pharmaceutical Intervention measures (e.g., wearing face mask, maintaining social distance, regular washing of hands and use of alcohol-based hand sanitizers);
- e. Fully vaccinated persons who test negative for COVID-19 after the post-arrival Day 2 test MUST continue to observe Non-Pharmaceutical Intervention measures (e.g., wearing face mask, maintaining social distance, regular washing of hands and use of alcohol-based hand sanitizers);
- f. Travelers reporting or developing symptoms of COVID-19 on arrival in Nigeria, or during screening will not be allowed to self-isolate and will be placed in institutional quarantine; and

***All Arriving passengers will undergo temperature screening, Yellow Fever Card verification and COVID-19 vaccination certificate verification as required***

**3. Transit Passengers**

- a. Passengers transiting and transferring through KIA will be required to be fully vaccinated and in addition adhere to COVID-19 testing requirements at the destination countries.

**4. Exemptions**

- a. Children under 18 years will not be tested at the Airport upon arrival
- b. Children between 10-17 years who are unvaccinated are to submit a 48 Hour negative PCR test prior to embarkation to Ghana
- c. Children under 10 years are exempted from pre-departure COVID-19 PCR testing and COVID-19 testing at the Airport upon arrival
- d. Airline crew are exempted from the pre-departure and arrival COVID-19 testing and should follow the Airline policy for testing.
- e. Passengers who arrive under emergency circumstances such as diverted flights will not be required to undergo testing if they do not leave the airport or remain in isolation in their hotel.

**5. Travelling with Pets**

- a. Travelling with pets into Ghana is allowed in line with guidelines of the Veterinary Services Directorate of the Ministry of Food & Agriculture.

**6. Departure Process- Passengers exiting Ghana**

- a. Passengers departing Accra will required to adhere to COVID-19 testing requirements for the destination countries.
- b. Departing passengers will undergo temperature screening at the entrance of Terminal 3 departures

**7. Wearing of Nose Mask** a. Wearing of nose mask is mandatory in all Airport Terminals and ancillary building

**8C. Vaccination**

Definition of Fully Vaccinated - A person is said to be fully vaccinated when he/she has taken the full dose of vaccines approved and registered by the Food and Drugs Authority (FDA), Ghana or other vaccines prequalified by WHO (<https://covid19.trackvaccines.org/agency/who>) as in Table 1.

All Passengers must present a valid COVID-19 vaccination certificate showing that they were fully vaccinated at least 14 days before embarkation except partially vaccinated or unvaccinated Ghanaians who are required to present a NEGATIVE 48hrs PCR test result to the airline before embarkation and to Port Health upon arrival.

It is also confirmed the possibility of entry into Italy, from List E countries, for persons who have a proven and stable emotional relationship (even if not cohabiting) with Italian/EU/Schengen citizens or natural persons who are legally resident in Italy (long-term residents), who need to reach their partner's home/domicile/residence (in Italy).
- Athletes, technicians, competition judges and officials, foreign press representatives and accompanying persons participating in competitive sports competitions, recognized to be of pre-eminent national interest with a provision of the Italian National Olympic Committee (CONI) and the Italian Paralympic Committee (CIP) and regulated by a specific safety protocol adopted by the sports organization responsible for the event.
- **Effective 29<sup>th</sup> April 2021 till 21<sup>st</sup> June 2021**; Ban on entry and transit in Italy of natural persons from (**India / Bangladesh / Sri Lanka**).
- The new order prohibits entry to Italy for people coming from India, Bangladesh and Sri Lanka or who have stayed in the countries in the preceding fourteen days. The entry ban does not apply to the following persons:

  - Obligation to undergo a further molecular or antigen test after the quarantine period.
  - Passengers arriving in Italy who do not meet the required requirements will be rejected with transport costs for repatriation to be borne by the carrier.
  - Instructions of countries in LIST (D):

- **Temporary travel restrictions apply to all non-essential travel from third countries to the federal republic of germany.**
- The restrictions do not apply to German citizens.
- Exempted from these travel restrictions are pax who have resided and last stayed in the following countries and regions: hong kong, indonesia, macao, new zealand, south korea, taiwan.
- In addition, entry into the federal republic of Germany is permitted to all pax who have resided and last stayed in third countries, provided they are fully vaccinated against sars cov-2 coronavirus
- Persons under 12 years of age who have not yet been vaccinated may enter if accompanied by at least one fully vaccinated parent.
- Due to reciprocity reservations entry into the federal republic of Germany is prohibited to passengers who have resided and last stayed in the following states: **China**. this does not apply to:
  1. German citizens
  2. EU citizens
  3. citizens of Liechtenstein, Switzerland, Norway or Iceland
  4. third-country nationals with current right of residence in Germany, other EU countries, Liechtenstein, Switzerland, Norway or Iceland
  5. 1st and 2nd degree relatives (grandparents, parents, children, grandchildren and siblings) of passenger listed under 1 - 4 above
  6. passengers who have resided and last stayed in Hong Kong, Macao and Taiwan.
- **The vaccine** must be listed on the website of the paul-ehrlich-institut or it must be mentioned by paragraph 2 no. 10 coronavirus entry regulations ('coronaviruse-inreiseverordnung'), which has not been approved by EMA (WHO Vaccines), but is considered as sufficient for the purpose of entry. pax must have received all the necessary vaccination doses required for a complete protective vaccination as listed on the website of the paul-ehrlich-institute. At least 14 days have elapsed since the last

required vaccination, except for recovered persons. pax has not stayed in an area of virus variants of concern during the last 10 days.

3. skilled and highly qualified foreign workers if their employment an economic perspective and the work cannot be postponed or performed abroad, )
4. Freight transport and other transport personnel,
5. Seasonal workers in agriculture,
6. Seafarers,
7. Foreign students, trainees, volunteers,
8. Persons immigrating into Germany for the purpose of joining their families and visits for urgent family reasons or short term visits of core family members (husband/wife, minor children, parents of minor children) or unmarried partners in a relationship with German nationals, Eu citizens and third-country nationals with current right of residence in Germany or joint short term visits of couples (third country national and german national/eu citizen) residing together in a third country for important reasons,
9. Persons in need of international protection or for other human itarian reasons,
10. diplomats, staff of international organizations, military personnel and humanitarian aid workers in the exercise of their functions,
11. ethnic German resettles,
12. Passengers in transit.

- **ENTRY FROM THIRD COUNTRIES INTO THE FEDERAL REPUBLIC OF GERMANY FOR THE SOLE PURPOSE OF ONWARD TRAVEL TO ANOTHER EU-/SCHENGEN STATE IS PERMITTED. THIS APPLIES UNDER THE FOLLOWING CONDITIONS:**

1. The time spent in Germany is limited to the duration required for direct transit to the destination state,
2. The third-country national is permitted to enter the destination state in accordance annex i or annex ii of the council recommendation (eu) 2020/912 of 30 June 2020 or an individual confirmation of the granting of entry issued by the destination state.) **EU entry ban for countries and areas not on the safe list** An EU entry ban applies to travellers from countries and areas outside the EU/Schengen area that are not on the safe list. If the purpose of your trip is on the list of exemption categories on this page, you can travel to the Netherlands. You can also travel to the Netherlands if you have valid proof of vaccination or proof of recovery. This proof of vaccination recovery must meet certain requirements

**B-Recovered from coronavirus**  
**If you are a resident of a country that is not on the list of safe countries and you have recovered from COVID-19, you may be exempt from the EU entry ban. You can enter the Netherlands if:**

- you recovered from COVID-19 at least 11 days ago; and you have proof of recovery: that is valid for a maximum of 180 days; and that was issued by a country taking part in the EU Digital COVID Certificate (DCC) scheme. [See the list of participating countries.](#)

**Proof of recovery from other countries will not be accepted. This exemption does not apply to travellers from China for as long as China continue to impose travel restrictions on travellers from Europe.**

**Documents required for entry into the Netherlands** If you meet the conditions for admission to the Netherlands after recovering from COVID 19, you must present the following documents at border control:

a [completed recovery declaration](#) (only for travellers aged 18 or over from non-Schengen countries);

[proof of recovery](#) recognised by the Netherlands;

proof you have booked a return journey (a return airline, coach or train ticket);

a visa (if required).

**C-Fully vaccinated**

If you are 12 years or older, a resident of a country that is not on the list of safe countries and fully vaccinated, you are exempted from the EU entry ban. You can enter the Netherlands if you have valid [proof of vaccination](#) showing that you have been fully vaccinated with a vaccine approved by the European Medicines Agency (EMA) or the World Health Organization (WHO). Children under 18 travelling with their fully vaccinated parent(s) or legal guardian(s) do not have to be vaccinated themselves.

This exemption does not apply to travellers from China until China lifts entry restrictions on European travellers.

**Documents to be shown at the Dutch border**

If you meet the conditions above and travel to the Netherlands, you will need to show the following documents to the Dutch border authorities:

- a [completed 'Vaccine Declaration COVID-19' form](#);
- [proof of vaccination accepted by the Netherlands](#);
- proof of your return journey (return ticket issued by airline, bus company or railway company);
- a visa (if you require a visa).

Travellers aged 12 and over from outside the Schengen area must complete a vaccination declaration. Children under the age of 18 travelling with their vaccinated parent(s) or legal guardian(s) are exempt from this requirement.

You are a key worker or have an essential role: care worker, doctor or nurse.

You are a cross-border commuter.

You are a seasonal worker.

You work in the transport sector:

- transport of goods
- container ships
- bulk carriers (e.g. transporting ore or coal)
- tankers (e.g. transporting fuels and chemicals)
- fishing boats.
- You work in the energy sector:
  - on an oil or gas platform
  - at an offshore wind farm

You are a member of the armed forces and need to travel to carry out your duties.

You work for an international and/or humanitarian organisation.

You are an elite athlete as defined in the framework for applying the [exemption for elite athletes and their support staff](#).

You are a researcher as defined in the framework for applying the [exemption for researchers](#).

You are a business traveller as defined in the framework for applying the [exemption for business travellers](#).

[G-Compelling reasons to visit your family](#)

You have compelling reasons to visit your family. This is only possible in truly exceptional cases, such as: visiting a seriously ill or terminally ill family member or attending a funeral. You must be a family member in the first or second degree (as defined in Dutch law). [You must fill in a Declaration of exemption from COVID-19 entry ban](#). coming to the Netherlands to be with your legal partner when they give birth. If you are not legally married, you must have acknowledged paternity or parentage of the unborn child. You must also be able to prove, with a letter from the gynaecologist or the obstetrician, that your partner is more than 34 weeks pregnant. visiting your grandchild or great-grandchild. From 00.01 on 16 September 2021 all grandparents and great-grandparents visiting grandchildren or great-grandchildren aged under 18 are exempt from the EU entry ban. This used to only be the case if you were visiting a newborn grandchild or great-grandchild. You must fill in a [Declaration of exemption from COVID-19 entry ban for visiting a grandchild or great-grandchild](#).

you are a divorced parent from a non-EU country and you want to visit your child who lives in the Netherlands. You must fill in a [Declaration of exemption from COVID-19 entry ban for visiting your child as a divorced parent](#)

[H-Transit, transfer](#)

**You are travelling through the Netherlands to a non-EU/Schengen area country.** You must prove that you have a connecting flight to a country outside the Schengen area. The connecting flight must depart within 48 hours of your arrival at the airport. You must not leave the airport's international transit zone in this period. Please note: the United Kingdom (UK) is not part of the EU/Schengen area.

**You are travelling to an EU country/Schengen area country via the Netherlands.** You must be able to show you have permission to enter the EU country/Schengen country in question. You can do this with a note verbale from that country's embassy, for example, or another type of document that proves you can travel there. If you do not have such a document, the Dutch border authorities will determine whether you may travel via the Netherlands. Without a document showing you have permission to enter the EU country/Schengen country in question, you are advised to fly there directly and not via the Netherlands. If you will be making a short stop at a Dutch airport you may [need an airport transit visa](#). This depends partly on your nationality. - **Effective from 15th June 2022**, persons who hold a vaccination record issued by relevant authorities of Bahrain, the Dominican Republic, Egypt or Mauritius in the prescribed format can board a flight for Hong Kong from overseas places. The vaccines administered for the relevant travellers have to be vaccines listed on the Government's List of COVID-19 Vaccines Recognized for Specified Purposes.

#### **Effective April 1<sup>st</sup> 2022**

1) **Passengers travelling from the nine place –specific suspension mechanism countries” Australia, Canada, France, India, Nepal, Pakistan, the Philippines, the United Kingdom and the United States of America”:-**

- Government will lift the place-specific flight suspension mechanism for the aforementioned nine places from April 1. **This is on the premise that the returning Hong Kong residents would still have to undergo compulsory quarantine in designated quarantine hotels (DQHs) under the measures guarding against the importation of cases, while the route-specific flight suspension mechanism would continue to be applicable with suitable adjustments.**

2) **Passengers travelling from overseas places:-**

- **Hong Kong residents** who have stayed in any overseas places in the previous 14 days can only board a flight for Hong Kong if they comply with the following conditions. Meanwhile,

**Effective May 1<sup>st</sup> 2022: non-Hong Kong residents will be allowed to board flights for Hong Kong from any overseas places and be subject to the same boarding, quarantine and testing arrangements as HKRs.**

(i) Fully vaccinated (**Note 1**) and hold a recognized vaccination record;

- **Fully vaccinated generally involves receiving two doses** of the Sinovac COVID-19 vaccine (CoronaVac vaccine) or the Fosun Pharma/BioNTech COVID-19 vaccine (Comirnaty vaccine)

14 days before coming to Hong Kong. Persons previously infected with COVID-19 who have received one dose of COVID-19 vaccine can be considered fully vaccinated. As for persons aged between 12 and 17 on the scheduled day of arrival at Hong Kong, they may be deemed to have completed the COVID-19 vaccination course on receiving one dose of the Comirnaty vaccine. For individuals who received COVID-19 vaccines in places outside of Hong Kong and have received the required dose(s) as stipulated in the [List of COVID-19 Vaccines Recognised for Specified Purposes](#) and the relevant guidelines, they will also be regarded to have completed the vaccination course of the relevant COVID-19 vaccine.

- (ii) Hold a negative result proof of a polymerase chain reaction (PCR)-based nucleic acid test for COVID-19 conducted with specimen collected within 48 hours before the scheduled time of departure of the aircraft, and
- (iii) Hold a confirmation of room reservation in a DQH for seven or 14 nights from the day of arrival at Hong Kong (depending on whether they could meet the relevant conditions and choose early discharge from compulsory quarantine as per local isolation and quarantine arrangements) (Note 2).

#### **PCR**

- The relevant persons will be subject to the "test-and-hold" arrangement upon arrival at the Hong Kong International Airport. Upon tested negative with a PCR-based nucleic acid test, they will be taken to DQHs by designated transport to undergo compulsory quarantine.
- As the relevant persons **have been fully vaccinated** (Note 1), under the isolation and quarantine arrangements of local cases (Note 2), if the results of the PCR-based nucleic acid test conducted on the fifth day and the RATs conducted on the sixth and seventh days are all negative, they can be discharged from compulsory quarantine earlier. However, they will be required to undergo self-monitoring for seven days, and undergo a compulsory PCR-based nucleic acid test on the 12th day of arrival at Hong Kong at a community testing center (CTC) or a mobile testing station (MTS), or arrange a self-paid test by professional swab sampling at a local medical institution recognized by the Government.
- **Children of Hong Kong residents aged under 12** are yet to be vaccinated can also board flights for Hong Kong if they are accompanied by Hong Kong residents who comply with the above boarding requirements. These children must also hold a negative result proof of a PCR-based nucleic acid test for COVID-19 conducted with specimen collected within 48 hours as stated above, and confirmation of room reservation in a DQH. The children must undergo compulsory quarantine together with the accompanying persons. If the results of the PCR-based nucleic acid test conducted on the fifth day and the RATs conducted on the sixth and seventh days are all negative, the children can also be discharged from quarantine earlier with the accompanying persons. Just as the accompanying persons, these children must undergo self-

monitoring for seven days, and compulsory testing on the 12th day of arrival at Hong Kong as per the requirements above.

- **If any result is positive from the "test-and-hold" PCR-based nucleic acid test**, the PCR-based nucleic acid tests conducted on the fifth day or the 12th day, or the daily RATs, the relevant inbound traveler will be arranged to undergo suitable isolation and treatment under the multi-tiered triage and treatment strategy as with local positive cases. Inbound travelers tested positive after arrival and have no obvious symptoms and no need for medical support will be transferred to a community isolation facility hotel and be issued an isolation order. Their isolation and discharge arrangements will be the same as those for local positive cases under isolation, **i.e. for those who are fully vaccinated**, they can be considered to have completed isolation upon receiving negative results from the RATs conducted on the sixth day and the seventh day after being tested positive

#### **Quarantine**

- The basic quarantine requirement for the relevant persons is to undergo compulsory quarantine for 14 days in a DQH, and they will be issued a 14-day quarantine order. They are subject to daily rapid antigen tests (RATs), as well as PCR-based nucleic acid tests on the fifth and 12th days of arrival at Hong Kong.
- The basic quarantine period for local close contacts is 14 days, and the basic isolation period is 14 days **for local positive cases who have no obvious symptoms and no need for medical support**. In view of factors such as community risk assessment and easing pressure on local human resources, the Government announced earlier that persons under isolation or quarantine, if they have received at least two doses of COVID-19 vaccines, may leave isolation or quarantine earlier on the seventh day if the results of their RATs on the sixth day and the seventh day are negative. The relevant arrangements will be adjusted as appropriate taking into account the developments of the local epidemic situation and community risk assessments
- To better utilize limited DQH rooms, inbound travelers should decide when making their DQH booking whether or not they will choose to be discharged from compulsory quarantine earlier upon fulfilling the relevant conditions in accordance with the above arrangements, and correspondingly reserve their DQH rooms for **seven or 14 nights**.

**A) inbound travelers who hold a confirmation of a seven-night room reservation in a DQH**, the quarantine order issued to them will indicate that upon fulfilling the above criteria for early discharge from compulsory quarantine, they will be considered to have completed their compulsory quarantine, and they must then depart the DQH.

**B) Inbound travelers choose to complete the whole 14-day compulsory quarantine period in the DQH**, they must at boarding hold a confirmation of a 14-night room reservation in a DQH. Persons who hold a confirmation of a 14-night room reservation in a DQH will not be arranged for early discharge from

- Passengers who stayed in (the UK, South Africa, Ireland, Israel, Brazil, United Arab Emirates, Italy, Austria, Netherlands, Switzerland, Sweden, Slovakia, Denmark, Germany, Nigeria, France, Belgium) within the last 14 days, must submit an inspection negative certificate of pre-entry test issued within 72 hours prior to departure.
- Passengers will be tested for Covid-19 at the airport and will be quarantined in the accommodation of the government. • On the third day after entry to the accommodation, passenger will be tested again. If the result is negative, the passenger will leave the accommodation. After leaving the accommodation, passenger must remain at home, etc. for 14 days after entering Japan.
- All passengers from designated countries / regions with “Corona Virus Variant confirmed for the first time in INDIA” are requested for the time being to stay at facilities designated by the Quarantine station.     - 5- All items must be written in English.
  - The test method is valid only for one of the following (real time RT-PCR / LAMP / TMA / TRC / Smart Amp / NEAR/ Next Generation Sequence or CLEIA/ ECLEIA)
  - Sample collection method is valid only for one of the following (Nasopharyngeal Swab / Saliva)
  - Another test will be done upon arrival.

#### **QUARANTINE:**

- All passengers arriving to Japan will be subjected to 6 days quarantine and will continue in home isolation till day 14 - even the PCR test which will be done on the 3<sup>rd</sup> and 6<sup>th</sup> day - are negative.
- All passengers arriving from Egypt shall undergo 14 days self-isolation.

## THAILAND

**Effective 01<sup>st</sup> of April 2022**, RT-PCR test is NO LONGER required if the passenger arrives at the first airport in Thailand

**Effective 01<sup>st</sup> March 2022**, the following instructions for passengers travelling to Thailand will be applied:

1-thailand pass

2-pcr test within 72 hrs before deparature

3-health insurance with minimum coverage of 20.000 USD for medical expenses

4-paid SHA extra+/AQ hotel booking confirmation for 01 day only including the fee for 01 RT-PCR test, 1AK self - test kit and airport transfer .

5-take ATK self-test on day 05 and report the test result as instructed by the ministry of public health.

### **Starting 01 February 2022**

#### **1. Test and Go Entry Scheme**

- **Effective from 1 February 2022, the Test and Go entry protocol will resume registration through the Thailand Pass system, and passengers are able to enter Thailand through this entry scheme accordingly;**
- **Travelers departing from ALL COUNTRIES are now permitted to enter through the Test and Go scheme;**
- **Please note that the requirements for registration under the Test and Go scheme are the same as previously announced with the addition that passengers are required to reserve 2 RT-PCR lab test in conjunction with two-night accommodation (Day 1 and Day 5).**

. Applicants who have registered, but have not received their QR Code must wait for their Thailand Pass to be considered / approved. Once approved, they can enter Thailand under the scheme they have registered.

. Passengers who will arrive in Thailand under Test and Go and Sandbox Programme must undergo their 2nd COVID-19 test using the RT-PCR technique (not ATK self-test) at government-designated facilities (no additional cost).

- Travelers who have been previously approved to enter Thailand under AQ scheme but wish to change to another scheme must re-register on Thailand pass.

## **2. Sandbox Programme**

**- Effective from 1 February 2022, Sandbox area will include Phuket, Krabi, Phan-Nga, Surat Thani (Koh Samui, Koh Tao and Koh Phangan), Chonburi (Pattaya and some districts) and Trat (Koh Chang);**

**- Requirements for Sandbox programme remains the same as previously announced.**

### **Effective 01<sup>st</sup> October 2021 (1700 UTC):**

- Visa on Arrival (VOA) is no longer suspended from 1 October 2021 onwards.
- Passengers on visa exemption scheme are permitted to stay in Thailand for 30 days.
- Cambodia and Myanmar passport holders can enter Thailand without visa and permitted to stay in Thailand for 14 days.
- All passengers willing to enter Thailand need to present (individual) COE and other required documents to Thai authorities upon arrival. If they failed to present the required documents, their entry would be denied.

### **Thailand's entry measures for Thais and non-Thais effective from 1 November 2021 (as of 31 October 2021) as follows:**

#### **1. Exemption from Quarantine (EQ) or Test and Go**

- On 30 October 2021, the Ministry of Foreign Affairs announces updated list of countries and territories that eligible to enter Thailand on this scheme. The announcement is attached herewith for your information.
- 17 additional eligible countries/territories for EQ are Croatia, India, Indonesia, Kuwait, Laos, Luxembourg, Maldives, Mongolia, Myanmar, Nepal, Oman, Philippines, Romania, Slovakia, Sri Lanka, Taiwan, and Vietnam (Currently, there are 63 eligible countries/territories).

#### **2. Sandbox Program**

- Unvaccinated Children under 18 year-old will be eligible to enter Sandbox Program if they travel with fully vaccinated parents or guardians.
- The second test during the stay in Sandbox Program has changed to ATK test on day 6th - 7th.

#### **3. Insurance**

- Thai nationals are not required to have medical insurance to enter Thailand.

- Non-Thais must obtain Insurance with minimum coverage of 50,000 USD during the period of stay in Thailand. Expats living and working in Thailand can provide a valid social security card or certified letter from their employer as equivalent document. This also apply to travellers who will travel to Thailand for international transit/transfer.

#### 4. COVID-19 RT-PCR Test issued within 72 hours before departure

- All travelers entering Thailand, regardless of age and nationality must present the RT-PCR test result.
- This doesn't apply to Thai nationals entering Thailand on AQ scheme.

#### 5. Thailand Pass QR code

- Travelers obtain either COE or Thailand Pass QR code are eligible to enter Thailand.
- The sample of Thailand Pass QR code is attached herewith for your information. You can scan the QR code by using your mobile phone to see the validity of the QR code.

According to the latest notification of the civil aviation authority of Thailand, permit for passenger aircraft will be given for flying over, flying into or out of, and taking off or landing at an international airport in Thailand only if the passengers or persons on board are one of the following categories:

- Thai nationals
- Persons with exemption or persons being considered, permitted or invited by the Prime Minister, or the head of responsible persons accountable for resolving state of emergency issues to enter the Kingdom, pertaining to necessity. Such consideration, permission or invitation may be subject to specified conditions and time limits.
- Persons on diplomatic or consular missions or under International organizations, or representatives of foreign government performing their duties in the Kingdom, or persons of other international agencies as permitted by the Ministry of Foreign Affairs pertaining to necessity, including their spouse, parents, or children.
- Carriers of necessary goods, subject to immediate return after completion.
- Non-Thai nationals who are a spouse, parents, or children of a Thai national.
- Non-Thai nationals who hold a valid certificate of permanent residency in the Kingdom, or permission to take up residence in the Kingdom
- Non-Thai nationals who have work permit or have been granted permission from government agencies to work in the Kingdom, including their spouse or children.
- Non-Thai nationals who are students of educational institutions approved by Thai authorities, including the parents or guardians of the students, except for students of non-formal educational institutions under the law on Private schools and of other similar private educational institutions

- Non-Thai nationals who are in need of medical treatment in Thailand, and their attendants. However, this shall not include medical treatment for COVID-19
- Non-Thai nationals who are permitted to enter the Kingdom under a special arrangement with a foreign country or have been granted permission by the Prime Minister.

- To enter the Kingdom, the persons above shall comply with Disease Prevention Measures for the Persons Entering the Kingdom to Prevent the Spread of the COVID-19 Disease Annexed to the Order of the Centre for the Administration of the Situation due to the Outbreak of the Communicable Disease Coronavirus 2019 (COVID-19) No. 7/2563 Issued on 30 June B.E. 2563 (2020).
- Airlines are responsible to check that the passengers must full fill documentation requirements, such as certification of entry, COVID-19 free certificated with PCR test insurance policy covering expense on quarantine or medical care in Thailand without the proper documents the boarding must be denied.
- Passengers or remissible persons will also be subject to disease control measures applicable at the airport of arrival which may be varied according to the seriousness of the situation

- The immigration officers have the power to deny the entry of non –Thai nationals who have been tested positive for COVID-19 or under the suspicion of being infected or who refused to undergo such a test.
- On 26 November 2021, the world health organization (who) announced new variant of concern (VOC) of Sars cov-2 or omicron among African countries including (Botswana, Eswatini, Lesotho Malawi, Mozambique, Namibia, South Africa and Zimbabwe).
  - The department of disease control ordered the passengers departing from 8 countries mentioned above and arriving at port of entry in Thailand from 28 November 2021 (00.01 am) onward must be quarantined for 14 days in alternative quarantine (aq) regardless of vaccination status. The passenger from the said countries who has already got Thailand pass as sandbox will be changed to quarantine (aq) 14 days by port health officers.
  - The travel ban of passengers from these 8 affected countries will be enforced on 1 December 2021. The airline shall not accept the passenger from these countries to depart for Thailand and arrive on 1 December 2021 (00.01am) onward. it must be noted that Thailand pass issued to the passengers from these countries will automatically void on 1 December 2021
  - Thailand pass registration is no longer available for register from today, 27 November 2021 in these countries.
  - The passenger from 8 affected countries who have Thailand pass may arrive at port of entry in Thailand until 30 November 2021 and must comply with quarantine 14 days protocol regardless of vaccine status
  - For all remaining African passengers (Africa-north/central/south), except these 8 affected countries, who have Thailand pass as sandbox will be valid thru 14 December 2021. from 15 December 2021, all African passenger (except 8 countries with travel ban) will be eligible for alternative quarantine 14 Days regardless of vaccine status.

In case the airlines require passenger to present a COVID-free certificate as an airline policy, all passengers, including Thai nationals shall comply with the airlines policy, otherwise the passengers shall be denied to board with the flight.
