### 1- MIDDLE EAST:

1	<u>EGYPT</u>	<p><u>Till 30/06/2020</u>, All international flights to / from Egypt are suspended</p> <p><b><u>Health Regulations to enter Egypt:</u></b></p> <ul style="list-style-type: none"> <li>• Passengers should wear face masks during the flight.</li> <li>• A Health Declaration form should be available on all the international flights.</li> <li>• A Health Declaration form should be filled by the Passengers before boarding the flight (at the departure airport) and to be delivered to The Quarantine Authorities upon arrival.</li> <li>• Airline must provide the Health Declaration form at the departure airports and insure that the passengers have filled and signed it before boarding the flight (on the international flights)</li> <li>• Passengers travelling to Egypt should be screened at the airport of departure.</li> <li>• Passengers who are suffering from a temperature (Equal / above) 38C or those who are suffering from one of the respiratory symptoms (cough / sneezing / shortness of breath ...etc.) are not allowed to board the aircraft.</li> <li>• Aircraft disinfection form should be delivered to The Quarantine Authorities upon arrival for the international flights.</li> <li>• The disinfection of the Aircraft and the disinfection of aircraft air conditions filters should be done according to WHO guidelines and the aircraft manufacturer, Aircraft will not be allowed to take off again till obtaining a sanitary quarantine approval from the Egyptian Quarantine Authorities.</li> <li>• In case of any of the respiratory symptoms appear on a passenger during the flight, all necessary precautions must be taken if possible by (separate the suspected passenger in an area far from the rest of the passengers / assign one of the cabin crew members to serve the sick passenger / provide a bathroom for the sick passenger only).</li> <li>• Passengers coming to Egypt will be followed up for 14 days by The Quarantine Authorities and Ministry of Health Offices.</li> <li>• <u>Global insurance are required from foreign passengers travelling to Egypt.</u></li> </ul>
3	<u>KSA</u>	<p><u>Till further notice</u>, All international flights to /from the kingdom of Saudi Arabia are suspended</p> <ul style="list-style-type: none"> <li>• Facilitate the return of health practitioners abroad who wish to return to Saudi Arabia, provided that they have a valid visa for re-entry, or permission from the Kingdom's representative offices abroad.</li> </ul>

(Airlines shall comply with that or will be fined)</u></li> <li>• All passenger shall possess before arrival to Lebanon an insurance policy covering all costs of COVID-19 treatment inside Lebanon throughout the duration of their stay in Lebanon.</li> <li>• All passengers except diplomats, members of international organizations and UNIFIL, shall possess before arrival to Lebanon an insurance policy issued by local or international insurance company, covering all costs of COVID-19 treatment throughout the duration of their stay in Lebanon. Such policy can also be done through an on-line application to be announced later.</li> <li>• <b>PCR:</b> <ul style="list-style-type: none"> <li><b><u>1- Passengers arriving from PCR countries:</u></b> <ul style="list-style-type: none"> <li>• Passengers arriving from countries that perform PCR test; <u>1-Europe:</u> (all countries except Italy, Sweden, Denmark, Spain, Armenia) <u>2- Africa:</u> (Egypt /Tunisia/ Morocco/ Algeria / Nigeria / Ghana/ South Africa / Central Africa ) <u>3- Asia</u> ( Saudi Arabia / UAE / Jordan / Bahrain / Iraq / Oman / Iran) shall undergo such a test at certified lab by the countries local authorities latest 96</li> </ul> </li> </ul> </li> </ul>

		<p>hours before departure to Lebanon and to show the result of the test at check-in counter, Passengers not having negative PCR test result are not allowed to board the plane departing to Lebanon.</p> <ul style="list-style-type: none"> <li>• All airlines shall collect 100USD or its equivalent in Lebanese pounds, according to the official exchange rate issued by Central bank of Lebanon on every passengers wishing to travel to Lebanon, except children under 5 years old, which is the cost of PCR test that every passenger shall undergo upon arrival to BRHIA through labs authorized by the Lebanese ministry of Public Health at the airport. The airlines will pay the collected amounts to the designated handling agents at BRHIA on bi-monthly basis i.e. every 15 days starting 1st of July 2020, then the handling agents will pay for the Labs which performed the tests based on bills stamped by the Ministry of Public Health.</li> <li>• Passengers will be informed by the tests results within 24 hours from their arrival date, during that time they shall stay in their residence place.</li> <li>• <u>Exemptions:</u> <ul style="list-style-type: none"> <li>A- Passengers who travelled out of Lebanon and will return within one week are exempted from doing PCR test at their departure station.</li> <li>B- Connecting passengers are allowed to board a flight from PCR countries without conducting a PCR test before departure.</li> </ul> </li> </ul> <p><b><u>2- Passengers arriving from Non-PCR countries:</u></b></p> <ul style="list-style-type: none"> <li>• All passengers except children under 5 years age arriving from Non- PCR countries shall be subjected to PCR test performed through Labs authorized by Lebanese ministry Public Health at the airport, airlines shall collect 100USD or its equivalent in Lebanese pounds, according to the official exchange rate issued by Central bank of Lebanon on every passengers except children under 5 years age which is to be paid through the airlines to the handling agents at BRHIA on bi-monthly basis i.e. every 15 days starting 1st of July 2020, and then they should be subjected to another PCR test 72 hours after their arrival to BRHIA, by a lab which will be designated by the MOPH medical team at the airport, that test will be on the passengers own cost.</li> <li>• Passengers will be informed by the tests results within 24 hours from their arrival date, during that time they shall stay in their residence place.</li> </ul> <ul style="list-style-type: none"> <li>• <u>Passengers who already arrived to Lebanon and their PCR tests results were positive shall follow the directives of the Ministry of Public Health in Lebanon until they recovered.</u></li> </ul>

UAE residents will be **allowed** to return back to UAE on the following conditions;

- Resident wishing to return must apply online for “Resident Entry Permit” on “<http://Smartservice.ica.gov.ae>”.
- Kindly be informed that the validity of the resident entry permit is 21 days only from obtaining ICA approval as per the immigration authority instructions.
- Residents must book their tickets with national carriers or any other airlines that operates flights to UAE after obtaining ICA approval.
- Returning residents will have to go through PCR SWAB test process upon arrival at AUH.
  - Returning residents must self-quarantine for 14 days at home or selective locations if necessary at own expense and must download Health Authority Approved mobile tracking Applications.
- Diplomatic passport holders is allowed to enter UAE
- **PCR: NO PCR is required for passengers travelling to Abu Dhabi till further notice.**

**2- Dubai / Sharjah: (for more information, refer to Circular no. 123 (I) / 2020/date 25/06/2020)**

- All arriving UAE Nationals and residents who are living in Dubai are required to download and register with the Dubai Health Authority “COVID19 – DXB Smart App” prior to leaving the airport.
- A banning of companion animals (Dogs and Cats) importation to UAE is applied from (Iran / Italy / China / South Korea).
- Hong Kong is no more banned and excluded of the list.

**A. Regarding Residents:**

- Residents are allowed to return back to Dubai as of June 22nd, 2020.
- Residents shall register and get approval for GDRFA not ICA anymore (for Dubai ONLY) on the following link:

- This Approval to be obtained as of June 22nd or After, while any other Approval obtained from ICA before June 22nd is still valid and can be accepted but for 21 days from date of issuance.
- **NO PCR** is requested from Residents before departure from Cairo, only PCR Test is to be conducted upon Arrival at Dubai Airport.
- Residents is to sign 2 forms at Check-in Counter and it’s the Responsibility of Airlines to be sure its filed and signed, as it will be collected from Passenger upon arrival:
  - Health Declaration (Please find it in last page #10 in Arabic Version)
  - Declaration of bearing costs of PCR test and Quarantine **only** if PCR test proved at arrival to be

(this form is not yet available, and we challenged Dubai airports to avail it, once available it will be shared)</p> <p><u>Please Print and distribute those forms to passengers at Check-In Counter until we will find a way to get stock from Dubai Airports if available!</u></p> <ul style="list-style-type: none"> <li>- Airlines have the right to deny travelers if they display any symptoms of COVID-19</li> <li>- No 14 days quarantine is required anymore except for those whose PCR tests results proved to be Positive, but Residents has to stay home until results released.</li> </ul> <p><b><u>B. Regarding Visitors/Tourists:</u></b></p> <ul style="list-style-type: none"> <li>- Visitors &amp; Tourists are allowed to enter Dubai as of July 7th, 2020 normally according to Visa Requirements on TIMATIC (don't accept any Visitors or Tourists with visas or those categories getting visas upon arrivals before that date).</li> <li>- <b><u>PCR:</u></b> 2 options are allowed to Passengers: i). to get PCR Certificate from Departure Station valid for 96 hours from date of issuance, ii). To conduct the PCR test upon arrival at airport, no liability on Airlines to verify that, just for passenger information.</li> <li>- If passenger to make the PCR upon arrival to DXB, then he/she has to stay at place of residence until PCR test results resolved.</li> <li>- Airlines to ensure passengers holding Medical Travel Insurance Certificate to cover his Stay duration in Dubai.</li> <li>- To sign the same 2 forms at Cairo required from Residents as above mentioned.</li> <li>- Airlines have the right to deny travelers if they display any symptoms of COVID-19</li> <li>- No 14 days quarantine is required except for those whose PCR tests results proved to be Positive, but Residents has to stay home until results released.</li> </ul>
8	<a href="#"><u>ISRAEL</u></a>	<p><u>Till 01/08/2020</u>, All Passengers who are not an Israeli citizens or resident are <b><u>not allowed</u></b> to enter ISRAEL, <u>including transit passengers</u> except for passengers who have a specific entry approval from The Population and Immigration Authority. The airline is responsible for returning the passenger whose entry into Israel is denied to his airport of origin.</p> <ul style="list-style-type: none"> <li>• Passengers from all states who are not Israeli citizen or Resident are <b><u>prohibited</u></b> to enter the state of Israel including transit Passengers, except for passengers that have a specific entry approval from THE Population and Immigration Authority. the airline is responsible for returning the passenger who is entry to Israel is denied to his airport of origin.</li> <li>• Transit process at Ben Gurion Airport is discontinued</li> <li>• All pets flying to Israel must obtain a written approval letter from the veterinary services at Ben Gurion Airport.<b><u>(for more information refer to Circular no. 121 (I) / 2020/date 24/06/2020)</u></b></li> </ul>

7	<a href="#"><u>TUNIS</u></a>	<p><u>(for more information, refer to Circular no. 124 (I) / 2020/date 26/06/2020)</u></p> <p>The new updates regarding the latest instruction to enter Tunis" and as a part of the gradual resumption of commercial flights to / from Tunisian airports from 27th June 2020,<u>Kindly be informed that:</u></p> <p>1- Tunisia has categorized the countries into 3 categories according COVID- 19 Infections (list is attached)</p> <p>2- EGYPT can be found in the third category (other countries)</p> <ul style="list-style-type: none"> <li>• Only Tunisian residing in these countries, foreigners residing in Tunisia and diplomats accredited in Tunisia from these countries will be accepted on flights to Tunisia.</li> <li>• Each passenger arriving from these countries must present a negative COVID-19 (Rt-PCr) test certificate, completed 72 hours before the flight date and up to 120 hours upon arrival in Tunisia.</li> <li>• Every passenger arriving from these countries must commit in writing in accordance with the commitment form attached to: <ul style="list-style-type: none"> <li>- Comply with the mandatory confinement for 7 days.</li> <li>- Carry out a second test of COVID-19 (Rt-PCR) after the end of this first week of confinement, at the expense of the Tunisian state.</li> <li>- Apply the self-containment measurement for the next 7 days.</li> </ul> </li> <li>• <b>All passengers arriving from these countries must choose a hotel to stay there during the mandatory lockdown period and pay in advance the accommodation costs and present the booking confirmation and payment document (voucher) upon check-in at the departure airport to Tunisia. The fare paid must include accommodation and transfer from the airport to the hotel.</b></li> <li>• <b>Airlines must not accept the check-in of a passenger without the booking confirmation and payment document (Voucher) upon check-in.</b></li> <li>• <b>If an airline accepts a passenger on their flight to Tunisia without ensuring that they have the booking and payment confirmation document (voucher), she will be responsible for covering the costs of her hotel accommodation for the required period of confinement, or</b></li> </ul>

**she will be responsible for her repatriation on the same flight.**

- The commitment form must be delivered by the passenger to the company duly completed and signed at check-in before boarding.
- Airlines must collect these duly completed and signed commitment forms from the passengers concerned before boarding the flight at the departure airport and hand them over on arrival in Tunisia to the airport responsible on arrival in Tunisia, who must verify that the number of passengers on board complies with the number of the commitments collected.
- No flight arriving in Tunisia will be allowed to disembark before the airline issues all of the signed and completed commitment sheets for all passengers on board.
- **All airlines are advised not to accept the check-in of a passenger on a flight to Tunisia from these countries if he doesn't present a certificate of negative analysis of COVID-19 and if he didn't give the company the completed and signed commitment form and if he didn't present the booking confirmation and payment document (voucher) at check-in.**
- Airlines must ensure the validity of documents provided by passengers.
- **Please note also that passengers from these countries must book their accommodation in the « Carribean World » hotel in Borj Cedria:**
